Introductory note

This introductory note does not form a part of the notice.

The following notice gives notice of the variation of environmental permits EPR/DB3007CD and EPR/DB3007FQ referred to in the status logs below and the replacement of those permits with a consolidated environmental permit. EPR/DB3007FQ will now cease as it has been consolidated with EPR/DB3007CD.

The Industrial Emissions Directive (IED) was transposed in England and Wales by the Environmental Permitting (England and Wales) (Amendment) Regulations 2013 on 27 February 2013. This variation implements the changes brought about by the IED for "existing facilities operating newly prescribed activities" and completes the transition of this facility from a waste operation to an IED Installation.

This Installation will operate Open Windrow Composting as described in Standard rules SR2012No8-composting in open systems at National Grid Reference TF 25835 12939.

The total composting period will vary with the nature of the feedstock, the composting technology employed and the intended application of the final product. Compost on site will be produced to PAS100 and the Compost Quality Protocol standards.

The maximum quantities of waste shall not exceed 75,000 tonnes per annum.

The schedules specify the changes made to the permit.
